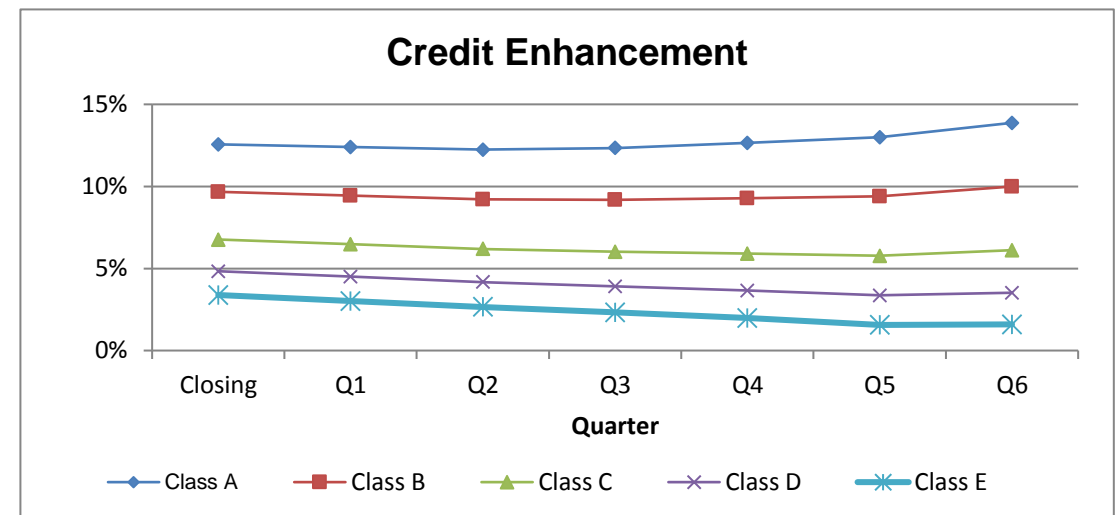

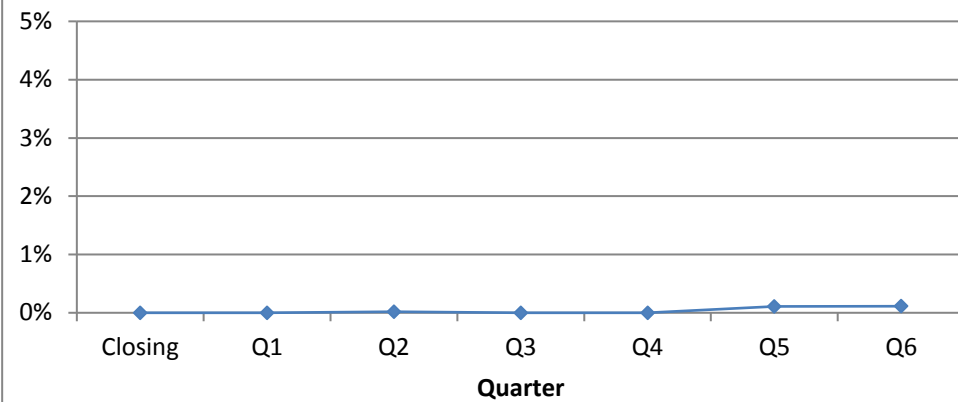

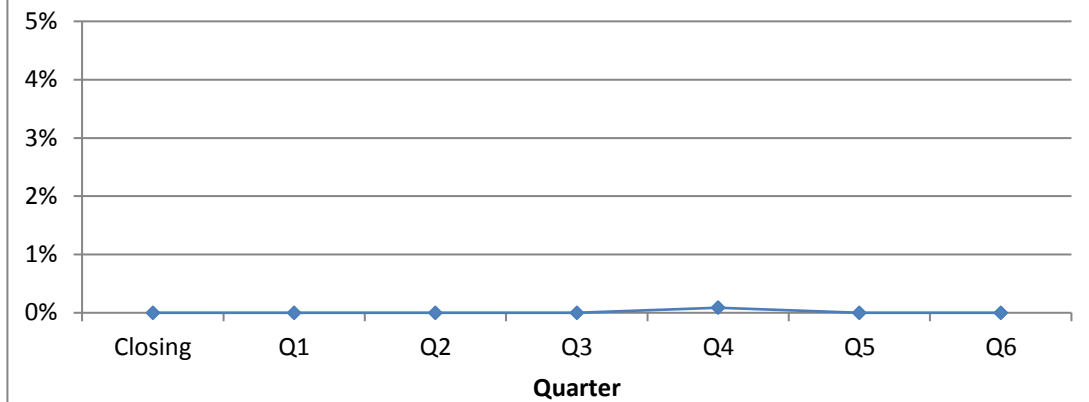

Delinquencies Graphs

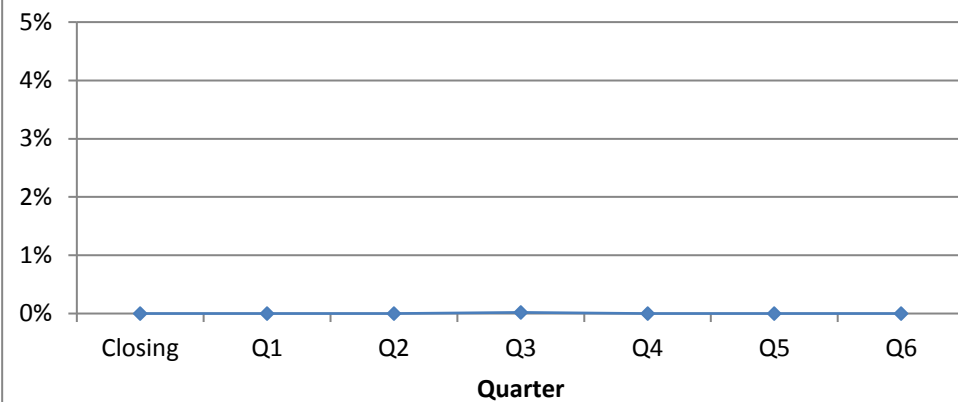
Delinquencies (30 < Days <= 60)



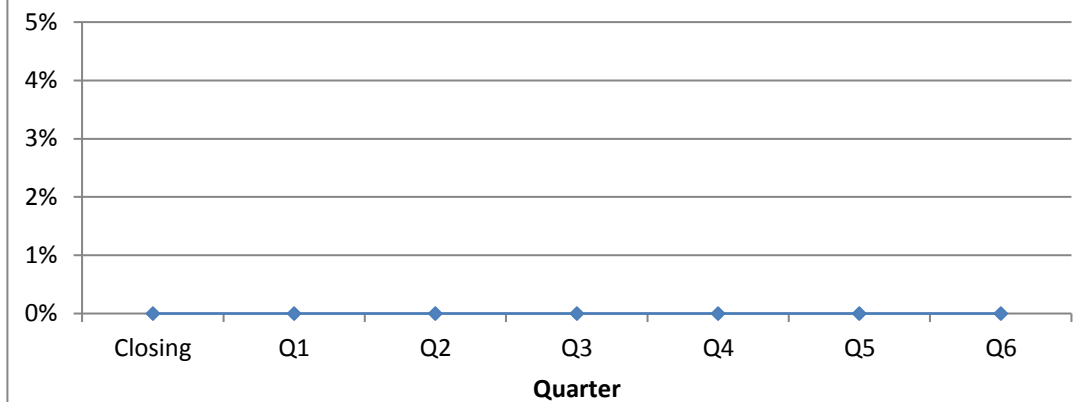
Delinquencies (60 < Days <= 90)
