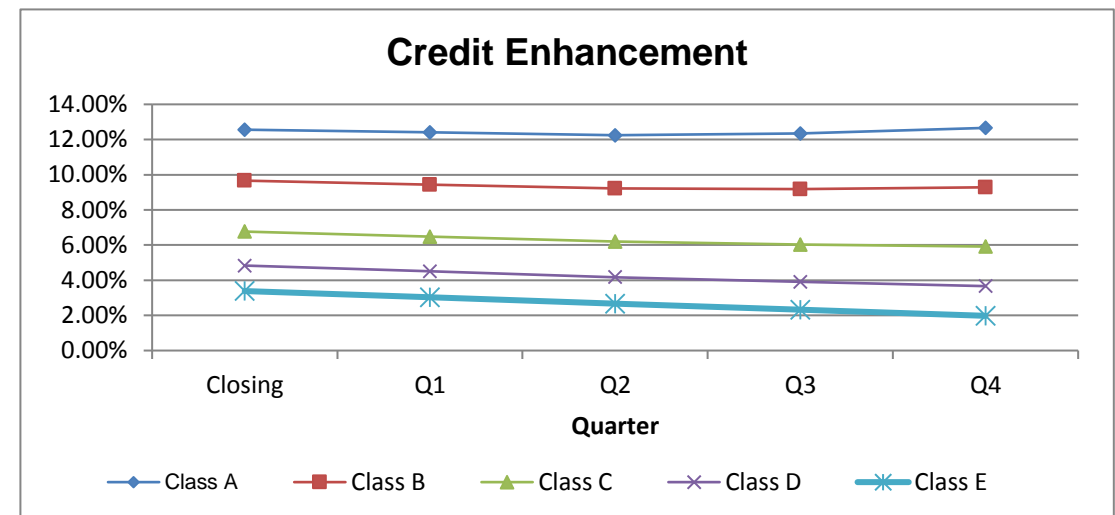

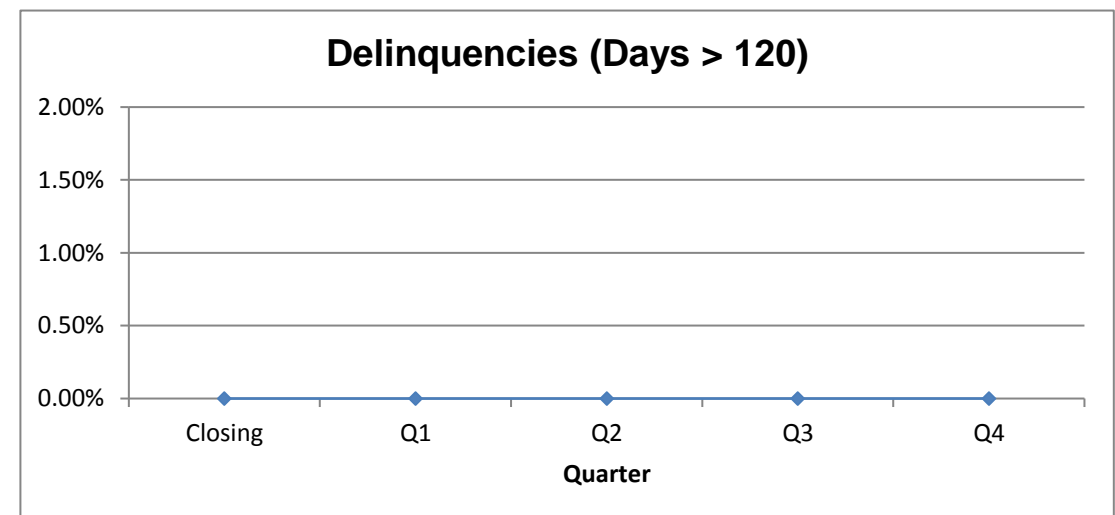
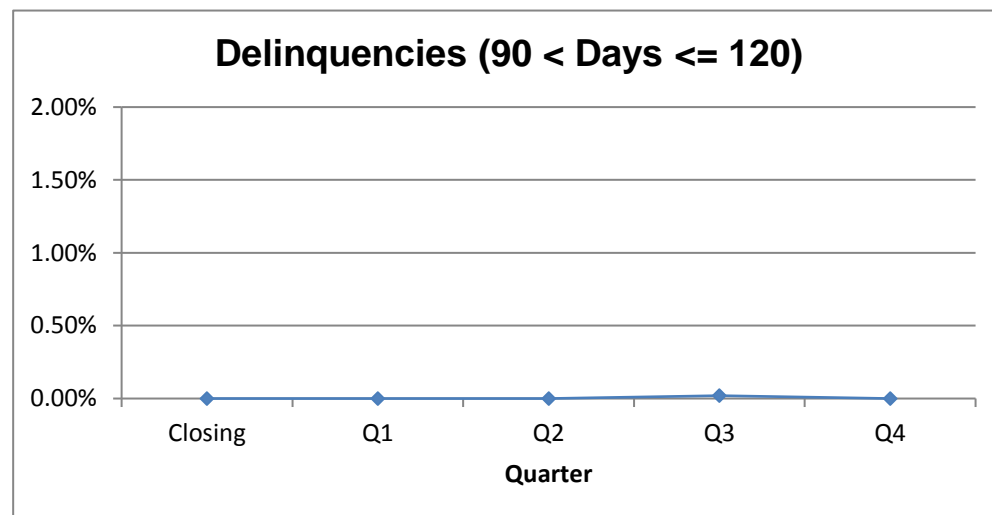
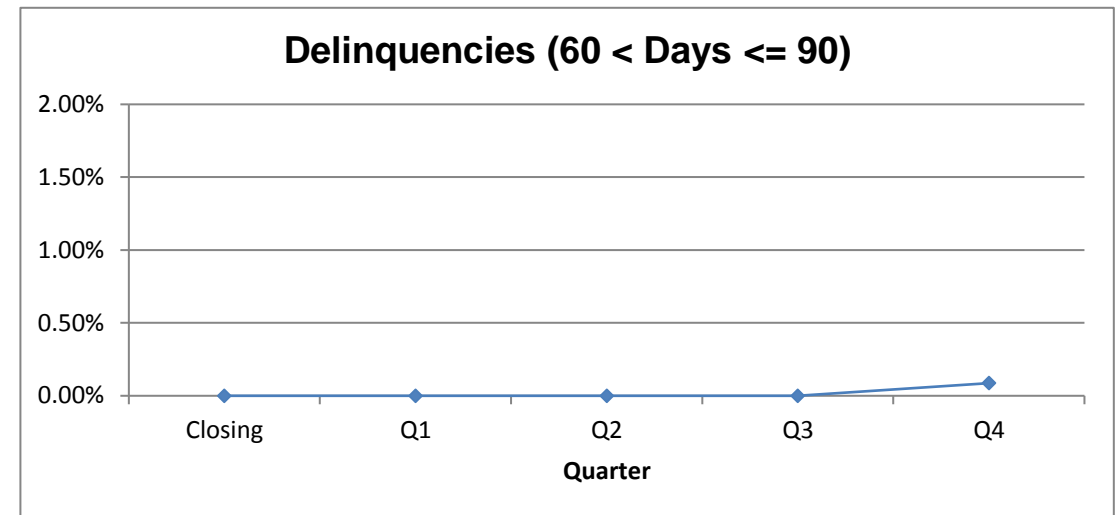
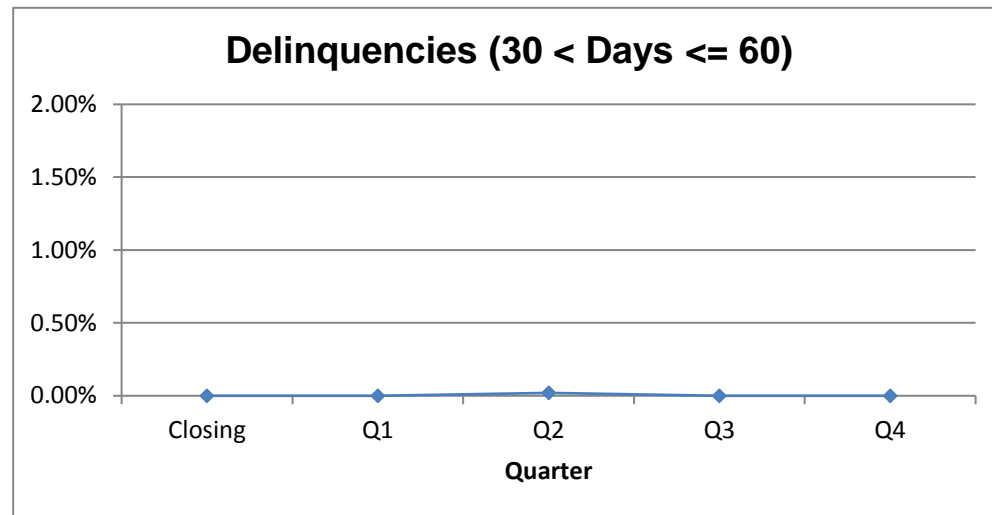
Collateral Performance Graphs
