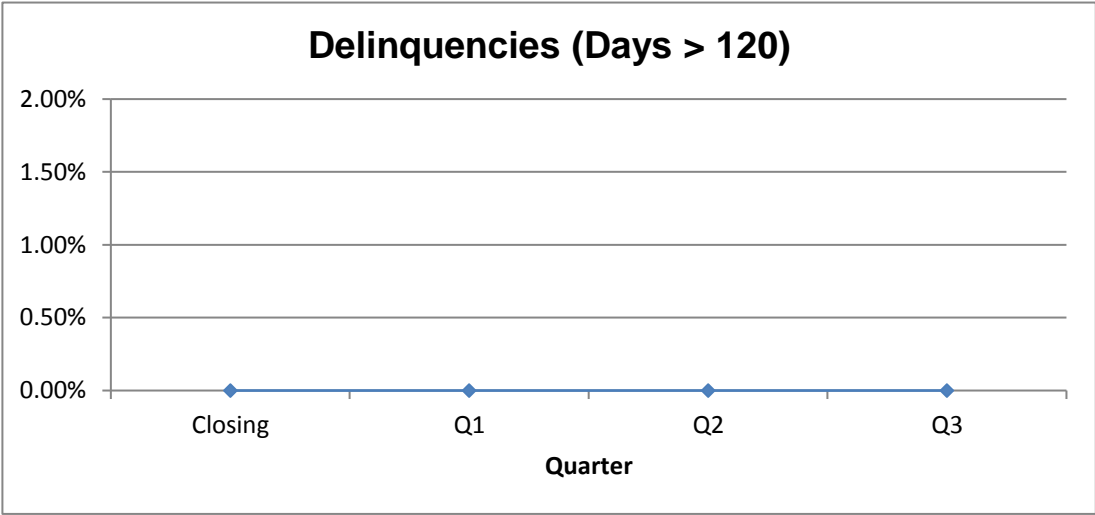
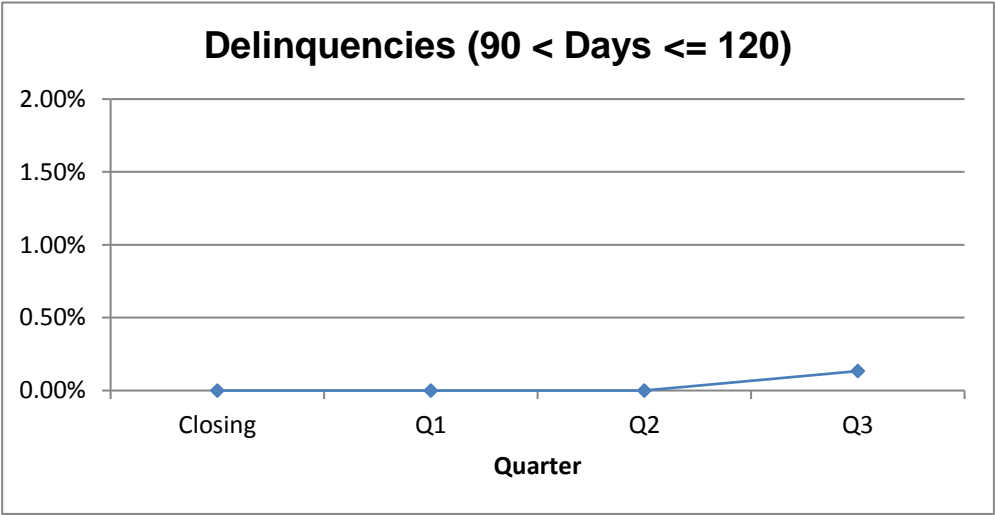
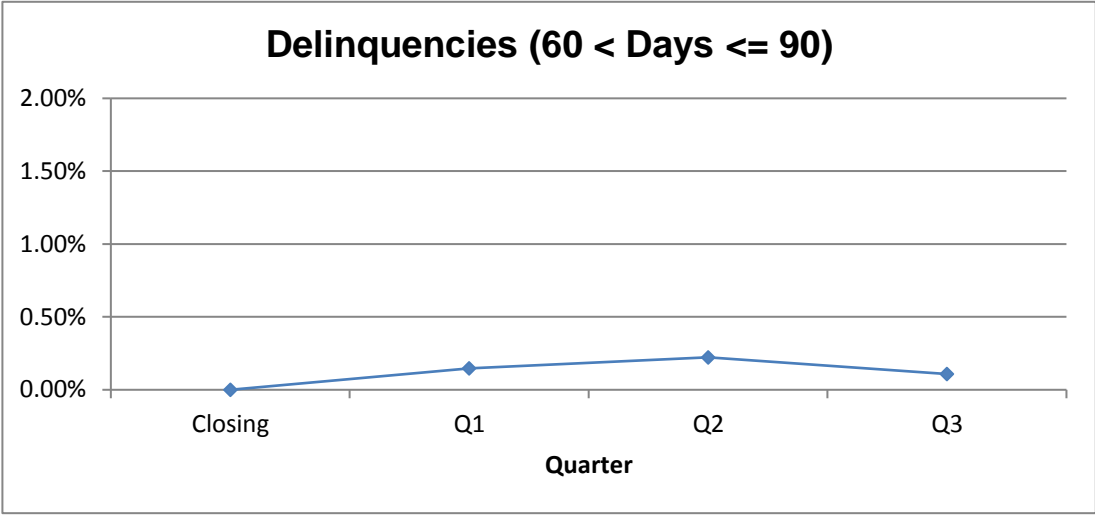
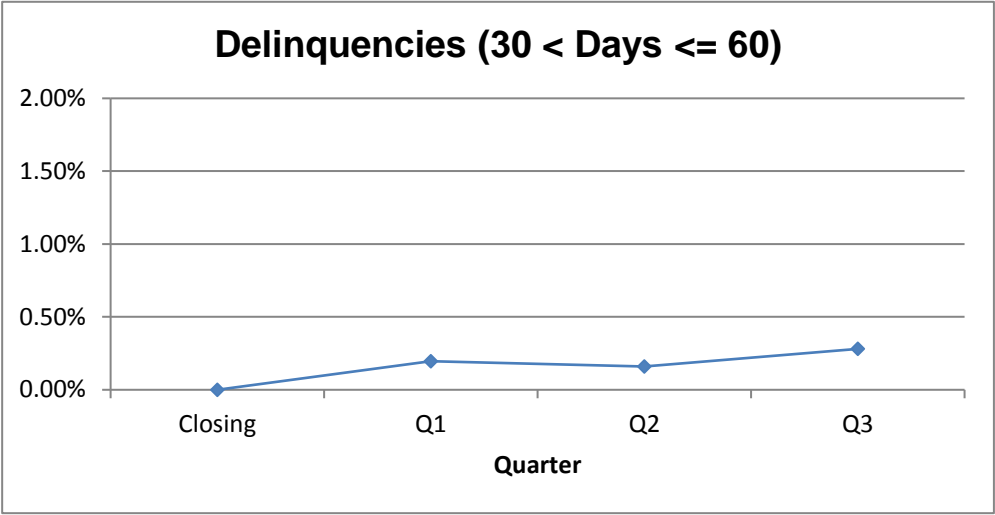
### Collateral Performance Graphs
