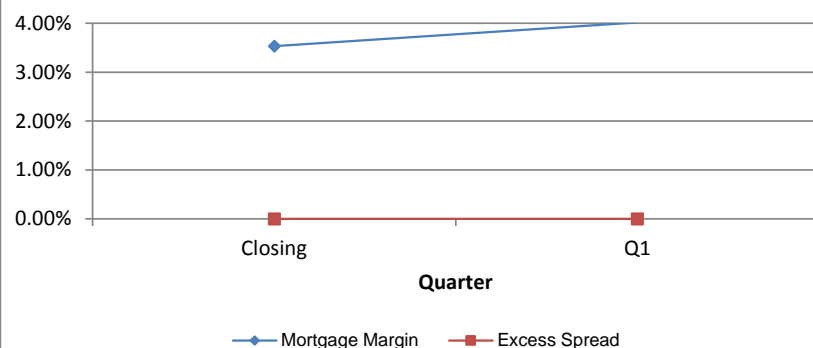

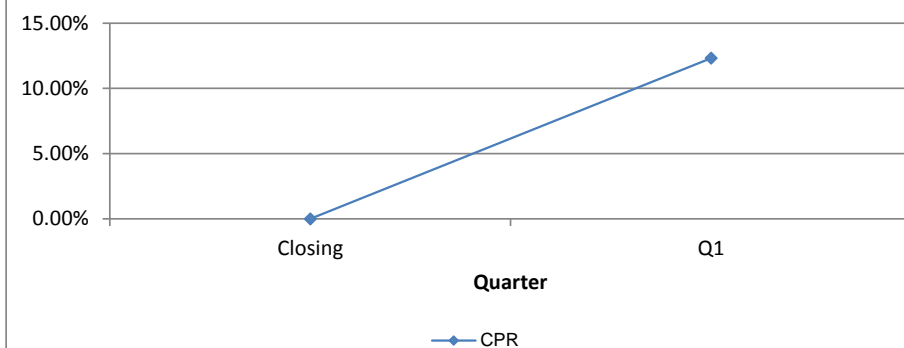

Mortgage Margin & Excess Spread



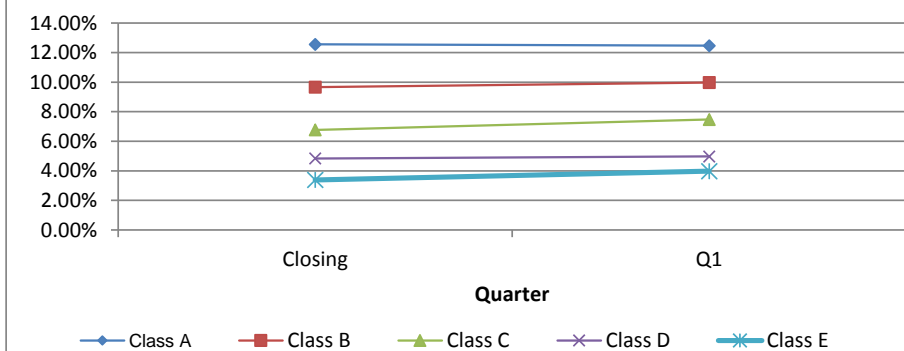
CPR



Cumulative Loss



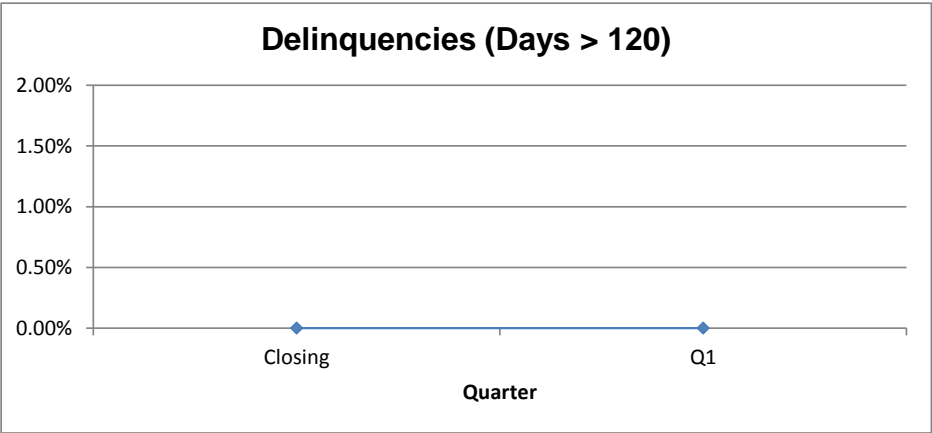
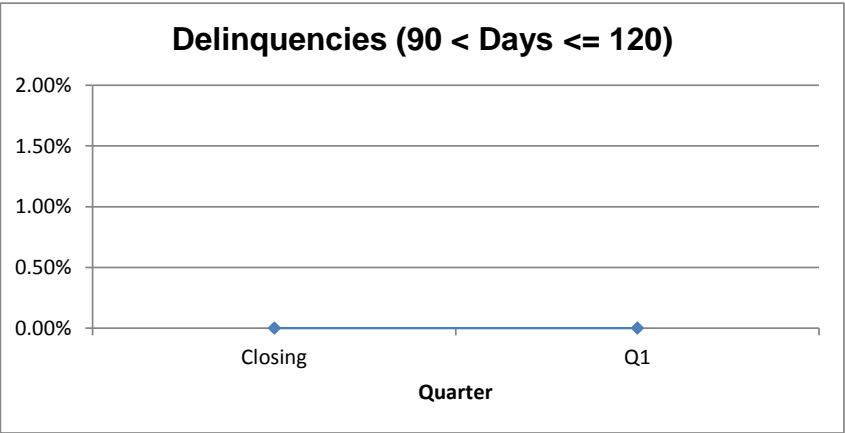
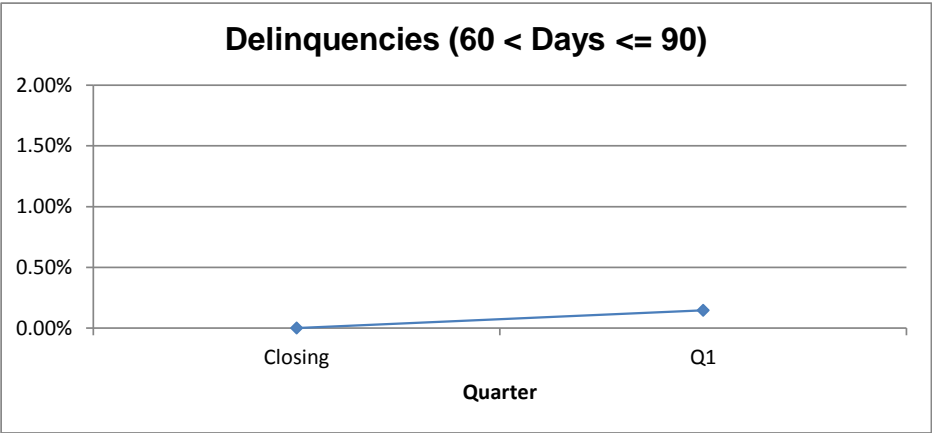
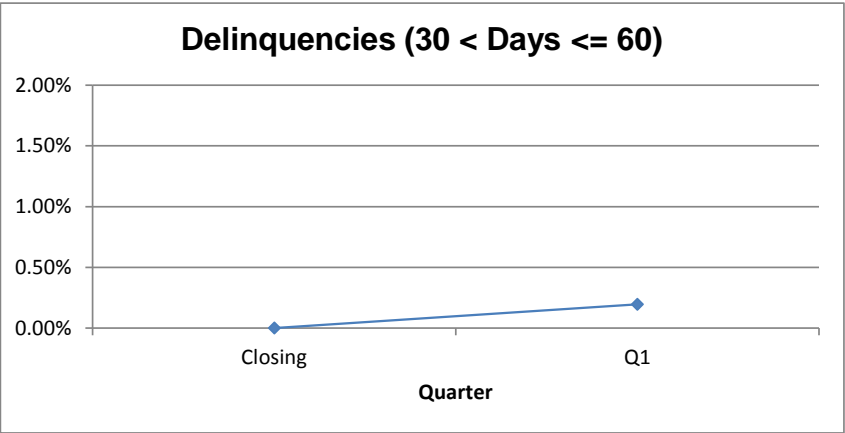
